敬啟者:

(一) 新學年防疫措施及注意事項

現時疫情仍未穩定,請家長及學生留意以下防疫措施及注意事項:

- 1. 響應教育局呼籲,家長應盡早安排子女接種疫苗,提高保護能力。
- 2. 學生回校前必須量度體溫及進行快速抗原測試(RAT),並在快測顯示棒上填寫檢測日期, 然後將結果(陽性或陰性)拍照,並通過 eClass Student App 上載至 eClass 系統。
- 3. 為保障全體教職員及學生安全,學校不會為學生在校內提供場地進行快測,如學生未有 檢測,必須回家,而非在學校附近的公眾場所進行測試。
- 4. 如學生經快速抗原測試對新冠病毒病呈陽性結果,家長應立即通知學校。如 貴子弟出現發燒或其他傳染病徵狀,應留在家中休息,切勿回校參與課堂或活動,家長須於早上八時前以電話通知校務處,並於復課後向負責老師呈交家長信。
- 5. 為計劃合適的學習活動,學校必須準確掌握學生接種疫苗及染疫的情況。請家長 從速更新接種疫苗或染疫記錄,並盡快向班主任遞交「2019 冠狀病毒病疫苗接種 紀錄」(即所謂「針紙」)或「康復紀錄二維碼」(如有)。

(二) 開學首星期安排

9月1日及2日舉行開學禮及開學感恩彌撒,上課時間由上午7:55至中午12:00。9月3日起依照特別時間表上課,放學時間為下午1:30。

(三) 家長手冊

<u>Circular No. 7</u> School Commencement

1. Health Protection Measures and Reminders for New Academic Year

Under the current severe Covid-19 situation, parents and students should pay attention to the health protection measures and reminders:

- a) In response to the Education Bureau's appeal, parents should arrange vaccination for their children as soon as possible to enhance their protection.
- b) Students must take a Rapid Antigen Test (RAT) before returning to school every day. Please mark down the test date on the rapid test stick, take a photo of the result (positive or negative) and upload it to the eClass system through the eClass Student App.
- c) In order to ensure the safety of all staff and students, the school will not provide a venue for rapid testing on campus. Students must go home instead of taking the test in public places near the school.
- d) Parents should notify the school immediately if a student is tested positive for COVID-19 by a rapid antigen test (RAT). In addition, if your child has a fever or other symptoms of infectious diseases, he/she should stay at home and do not return to school for classes or activities. Parents must notify the school office by phone before 8:00 a.m. and submit the parent letter to the teacher in charge on the next day.
- e) To facilitate the planning of learning activities, the school must have the most updated vaccination and infection records of students. We urge parents to update their child's vaccination and infection records as soon as possible and submit the "2019 COVID-19 vaccination record" and "recovery record QR code" (if any), to the class teacher as soon as possible.

2. The first week of the school year

There will be a School Commencement Ceremony and Mass on 1st and 2nd, September 2022. Teachers will also conduct class affairs on these two days from 7:55a.m. to 12:00 noon. Normal school days (Special timetable) will start from 3rd September 2022. Dismissal time is 1:30 p.m.

5. Portraiture Right

All student photos and videos of activity will not be used for commercial purpose. The school will reserve the right to use the portrait in school publication for promotion and recording purpose. Parents may submit application letter if you do not agree with it.

6. Campus Surveillance Cameras

Surveillance cameras have been set up in the public areas on school campus for school security. Students' appearance will be captured. Recorded file will be deleted within 12 days.
